Sajjad Hossain will participate in this programme under the following terms and conditions:

- a) He will start his journey for Austria on the above-mentioned dates or nearest possible date to attend the in-class session at IACA;
- b) The total period of staying in the in-class session of this programme and the time spent for travel and transit will be treated as on duty;
- c) He will draw his usual pay and allowances from ACC, Bangladesh in local currency;
- d) All expenses of the said course will be borne by the IACA including 8(eight) times travel expense (Air fare) to and from Bangladesh; and
- e) After completion of each module and on return from abroad he will have to report to the present place of posting.
