 - (e) They will leave Dhaka for Abu Dhabi, United Arab Emirates on 13 December 2019 or the nearest possible date and leave Abu Dhabi, United Arab Emirates for Dhaka on 21 December 2019 or the nearest possible date; and
 - (f) After the Conference, Hon'ble Chairman Mr. Iqbal Mahmood will visit to Canada and the U.S.A for meeting his family and friends from 21 December 2019 to 12 January 2020. Hon'ble Chairman will leave Dhaka for Abu Dhabi, United Arab Emirates on 13 December 2019 or the nearest possible date and leave Abu Dhabi, United Arab Emirates for Canada on 21 December 2019 or the nearest possible date. Hon'ble Chairman will bear all expenses of his private visit to other countries (except Abu Dhabi, United Arab Emirates) as mentioned above.
